Διά του παρόντος ανακοινώνεται συνημμένα, προκήρυξη και συνοδευτικό υλικό του Σλοβενικού Υπουργείου Παιδείας, Επιστημών και Αθλητισμού για τις υποτροφίες που προτίθεται να χορηγήσει, σε Έλληνες πολίτες και πολίτες άλλων χωρών, σε εφαρμογή διμερών Μορφωτικών Προγραμμάτων για το ακαδημαϊκό έτος 2022-2023.

Την υλοποίηση του προγράμματος υποτροφιών αναλαμβάνει η αρμόδια εθνική αρχή της Σλοβενίας CMEPIUS (Centre of the Republic of Slovenia for Mobility and European Educational and Training Programmes).

Οι υποτροφίες για Έλληνες πολίτες είναι 10 τον αριθμό με διάρκεια από 3 μήνες έως 10 μήνες. Στους υποτρόφους χορηγείται χρηματικό βοήθημα ύψους 300€ μηνιαίως, επιδότηση διατροφής ύψους 2,69€/ημέρα, ενώ παρέχεται δωρεάν διαμονή σε Φοιτητικές Εστίες Πανεπιστημίων καθώς και δωρεάν βασική ιατροφαρμακευτική περίθαλψη. Σημειώνεται ότι η προθεσμία υποβολής αιτήσεων λήγει στις 31 Μαρτίου 2022.

Bilateral scholarships for the academic year 2022 / 2023

GENERAL INFORMATION

The Ministry of Education, Science and Sport of the Republic of Slovenia (hereafter referred to as the "Ministry") hereby offers the number of scholarship months to foreign nationals, on the basis of bilateral agreements (between the governments/ministries) and reciprocity with the following countries:

Scholarships are awarded to applicants nominated by the competent authorities of eligible countries.

This scholarships scheme is designed for university/college students or graduates and Ph.D. applicants who wish to accomplish a part of their study at one of the Slovenian Higher Education institution. A part of postgraduate study is based on individual works under the supervision of Slovenian professor/mentor.

Its length usually ranges from **3 to 10 months** depending upon the agreement concerned that specifies also the categories of eligible recipients.

The scholarship **cannot be awarded for a complete course of study leading to a degree.**

Neither can the scholarship be granted for any Slovenian language course.

Please note that **tuition fee can not** be covered from this scholarship.

Majority of the applications are admitted for short time **study stay or research visits by doctoral students/candidates** (i.e. they either attend non-degree courses of their choice, or pursue an independent research activity at the host institutions, depending on their qualifications and preferences). In compliance with the applicable legal regulations, decisions on admission to research or study stays are taken by the institutions of higher education. **Applicants are therefore obliged to contact the selected university directly and request a Letter of Acceptance from the relevant department.** Applicants are requested to point out to the selected university that they are applying for a scholarship award under the bilateral agreement.

The age limit of the applicants for study stays is 26 years (the applicant may not complete 26 years of age before the end of the scholarship period) and 30 years for research visit.

The applicants for study stays should be **proficient in the Slovene language**, unless the **working language** is agreed upon with the mentor/supervisor.

All applicants should indicate the preferred period of scholarship in their application form. The Ministry reserves the right to change the requested term of scholarship and/or place any applicant to a course and/or higher education institution different from those indicated in his/her scholarship application form, if admission as requested by the applicant is not feasible.

Additional information and conditions:

Student mobility can be carried out only when student activities are taking place physically and when corresponding student dormitories are open and accepting students.

Student is eligible to receive scholarship only for physically mobility.

APPLICATION PROCEDURE

The implementation of this scholarships programme in the Republic of Slovenia is assigned to the national agency: CMEPIUS – Centre of the Republic of Slovenia for Mobility and European Educational and Training Programmes.

The nominations (main and reserve list) and application dossiers of applicants must be submitted to the CMEPIUS by the competent authorities (usually respected ministries of education, government agencies) of eligible countries.

Applications sent by individual applicants directly to the CMEPIUS will not be processed.

Competent authorities present the nominations before the deadline set in the relevant agreements, in most cases **by March, 31 2022**. The closing dates for applications fixed by the competent authorities are necessarily earlier (normally by several months). Prospective applicants are therefore advised to contact the respective competent authorities in time.

Each **application dossier must comprise a copy of a completely and legibly filled out Application form and Letter of Acceptance*** with the following required **attachments** which are also submitted in **duplicate**:

- a photocopy of ID card or passport (page with the photography),
- one Letter of recommendation for study stays and two Letters of recommendation for research stay from applicant's home institution,
- photocopy of diploma and/or certified transcript(s) of records,

All these documents must be written in or translated into Slovenian or English language. Incomplete application dossiers and/or inadequately completed application forms will not be processed.

Advice and further information can be provided by CMEPIUS using e-mail: scholarships@cmepius.si and by the Slovenian Embassies in eligible countries.

*The scholarship cannot be awarded unless the original »Letter of Acceptance« signed and sealed by the Slovenian higher education institution – applicant's future host institution is attached to the application.

PRACTICAL DETAILS

The scholarship is awarded upon the decision issued by the Ministry. The applicants and the respective authorities will be notified by the CMEPIUS in May/June 2022.

There is no legal claim to the scholarship award.

The scholarship is not transferable to another person.

While having this scholarship student can't receive Erasmus, CEEPUS or any other European Union sponsored scholarship.

For the academic year 2022/2023, the scholarship comprise of:

- **300 EUR* per month** - its amount is periodically reviewed and adjusted each January*
- **free accommodation** in the facilities (student dormitory) of the Student Centre of the Universities (paid for by the CMEPIUS directly to provider)
- **Subsidised meals - 2,69 EUR/per working day** via Student Organisation of Slovenia
- **basic medical insurance** for non-EU applicants if there is no bilateral agreement on health insurance between Slovenia and the applicant's home country (paid for by the CMEPIUS directly to provider)

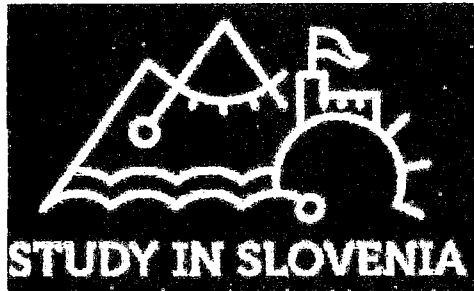

Step by Step Guide for Students

From making a decision to come to Slovenia and do your exchange to going back home

1. The information about student exchange to Slovenia you can find at various websites, www.studyinslovenia.si is the most comprehensive.
2. Once you have seen our web site and read all about it in the Invitation for bilateral scholarships, you need to contact your local authorities to check the deadline in your country. Our deadline 31. March each year is for the authorities to send the applications to CMEPIUS, not for students to apply, so usually the local authorities give local deadline before the end of March.
3. At the same time, you need to contact the faculty in Slovenia where you would like to go (get in touch with the international office, introduce yourself, send an e-mail, CV and explain what would you like to do here and when you would like to come).
4. After a positive response from your host institution, you need to submit an on-line application. Do not forget to print it out and together with all demanded enclosures, send it to your local authorities.
5. CMEPIUS waits for all applications to arrive and in May, the Commission for foreign students assembles and makes a final decision awarding or rejecting your application.
6. After the decision of the Commission, CMEPIUS informs students about the decision and sends some basic information by e-mail.
7. You need to answer the e-mail we send to you to accept or decline the scholarship, or you have to send some additional documents in order to award the scholarship and you have to send us the address where to send you General info package so you will receive it for sure.
8. In May/June, you will receive the General info package to your address. You read it, check if all the data are correct and send back the Letter of acceptance (this is the only letter you send back the rest you keep).
9. Now you prepare for the trip: prepare your health insurance, check expiring dates of your documents, arrange your visa if you need it, read General info package, so you won't forget something, buy you plane ticket, pack your bags and off you go.
10. After arriving to Slovenia go to your accommodation (usually student dorm).
11. Than you meet your host institution and your mentor and/or contact person.
12. Host institution contacts CMEPIUS and we send them your contract by e-mail, which you sign (it is very important that you read it before you sign it).
13. When all three parties (you, the dean of your host institution and the director of CMEPIUS) sign the contract, CMEPIUS transfers the funds to your host institution. The institution then transfers the funds to you so we advise you to ask your mentor or contact person, where you can collect the funds.
14. At the end of your exchange ask your mentor or contact person for the Letter of Confirmation. One copy needs to be sent to CMEPIUS and one copy is yours.
15. Finally yet importantly, after your exchange, you will receive an e-mail from CMEPIUS with a link to an on-line report that you need to fill in and submit.

INSTRUCTIONS FOR ALL THE ENCLOSED DOCUMENTATION AND FURTHER DETAILS ON YOUR STAY IN SLOVENIA

Dear grant holder

Please follow these instructions carefully. The following lines will tell you what to do with which document, which to send to whom and to which address. By strictly following the instructions, you can avoid many unnecessary complications.

So, what do you do after receiving the documentation from Slovenia?

Step 1: (MOST IMPORTANT!!):

Check the awarded number of months, dates of arrival and departure (from-until), host institution and your details (name and date of birth).

- If there is a mistake, **immediately contact** CMEPIUS (scholarships@cmepius.si)
- If everything is OK, sign the Letter of Acceptance **on both sides**. Then **send this document 3 weeks prior to your arrival at the latest**, to the CMEPIUS address:

If you decline the scholarship, you must inform us about your decision in writing (e.g. by e-mail) 3 weeks prior to your arrival at the latest or as soon as possible!

Step 2: REQUEREMENTS FOR A RESIDENCE PERMIT

Citizens of the European Union may enter the Republic of Slovenia without a visa or a residence permit, regardless of the purpose of their residence in the Republic of Slovenia (they only need a **valid identity card or passport, which must be valid until 6 months after the end of the exchange**). However, citizens of the EU have to report to the local authorities (at »Upravna enota«) if **your stay is longer than 90 days** with the 'Letter of Confirmation' in order to obtain a residence permit (it is enclosed with the Info package).

The student is obliged to register with the local police authorities after arrival:

- If you get a room in a student dormitory, the registry office will register you after arrival at the dormitory
- If you have **your own** accommodation, you need to arrange the registration **yourself**.

The requirements for residence registration (if your stay is longer than 90 days) are:

- Valid identity card or valid passport
- Health insurance covering all health risks in the host state (see next point for details)
- Sufficient financial resources for the period of residence (**Letter of Confirmation**).

The residence registration is valid during the time of studying or for one year if the study lasts longer; in this case it, can be renewed annually.

Step 3: HEALTH INSURANCE

To acquire health insurance, **citizens of the European Union** should bring with them a **European Health Insurance Card – EHIC**. We also recommend having some commercial insurance like CORRIS.

Step 4: ACCOMMODATION

Accommodation will be arranged for you in a student dormitory for the period of the awarded mobility grant and paid for by the Slovenian Ministry. The organisation of the accommodation depends on the University you are visiting (see below). The room will be available from the date of your arrival, which you will state in the letter of Acceptance (a maximum of 3 days before the start of the mobility). ***If you arrive before that date, you will not be able to enter the student dormitory. If you arrive later than agreed without prior notification, the room will be rented to other students.***

There are no additional funds available if you decline already reserved student dormitory accommodation. Additional funds are available when accommodation cannot be provided in student dormitories.

There are no single rooms at the dormitories.

A) Students staying in Ljubljana:

- ➔ **Before coming to Slovenia, read the instructions at <http://www.stud-dom-lj.si/en> and contact the dorm at sprejemnapisarna@stud-dom-lj.si**
- ➔ You need to bring the 'Letter for the accommodation' and your passport
- ➔ You can **ONLY** move in during working hours (see below)
- ➔ On the day of your arrival, you need to go directly to the reception office (address: Student Campus Rožna dolina, Svetčeva ulica 9, Ljubljana) where you will get the keys and the accommodation contract. They will also register you with the police authorities.
- ➔ At the dormitories, you will also receive some documents. Please read them so that you know the rules and procedures at the dormitories (moving in and moving out).
- ➔ You will need to check in at the reception office on a working day during working hours. ***If your arrival is on a weekend OR outside working hours, you will need to arrange your own accommodation for that time.***
- ➔ You can find a map at <http://www.stud-dom-lj.si/si/domovi/lokacije/>
- ➔ **Working hours of the reception office:**

Monday, Tuesday, Thursday: 9:00-12:00 and 12:30-14:00

Wednesday: 9:00-12:00 and 12:30-16:00

Friday: 9:00-12:00

On the first working day of the month, the office hours are from 12:00 to 14:00, except on October 1st.
Check the moving out procedure during/before the holidays.

Step 5: DURING YOUR MOBILITY

Get to know your host institution and SLOVENIA PRIOR TO ARRIVAL -> **check the websites** or e-mail your mentor and/or relevant person if you have questions about the programme of your work. You will find details in the document entitled 'Detailed information on your mobility'. You do NOT need to send anything to your host institution, though you **MUST contact them and introduce yourself before your actual arrival in Slovenia.**

For all student-related matters (student ID and discount coupons), contact the international office of your local student organisation and/or the international office at your host institution.

After arrival and checking in at the student dormitory, report to your mentor and/or contact person and ask them to contact CMEPIUS for your contract.

HOW TO GET THE SCHOLARSHIP FUNDS:

1. After your arrival in Slovenia, go to your mentor and/or contact person at your host institution
2. The host institution contacts CMEPIUS and we will send them your contract by e-mail
3. You sign the contract **(READ BEFORE YOU SIGN!)**
4. When all 3 parties (you, the dean of your host institution and the director of CMEPIUS) have signed the contract, CMEPIUS transfers the funds to **your host institution**
5. With your copy of the signed contract, you can get the funds
6. Ask your mentor or contact person where you can collect the funds
7. **Please have some money with you for the first month of your stay.**

VERY IMPORTANT: as stated in the Package and Letter of Acceptance, you need to notify CMEPIUS about any change IMMEDIATELY (at the latest, 1 month before your arrival, by e-mail scholarships@cmeplus.si or by phone +386 (0)1 620-94-59 (Petra). Failing to do so means that your accommodation and financing will no longer be guaranteed. Example: if something goes wrong and you are unable to come on the date your scholarship starts

and if you let us know about it, we can re-book the room. If you do not notify us about changes and you arrive later than planned, there will be no room waiting for you and CMEPIUS cannot guarantee accommodation.

LETTER OF ACCEPTANCE by Slovenian Higher Education Host Institution
